TOWN COUNCIL MEETING SCHEDULE

AN ORDINANCE OF THE LEEDS TOWN COUNCIL ESTABLISHING A TIME FOR HOLDING WORK MEETINGS AND REGULAR TOWN COUNCIL MEETINGS

WHEREAS, the Town Council of the Town of Leeds has held a Town Council Meeting on the 12nd day of November 2008; and discussed the 2009 meeting schedule; and

WHEREAS, the Town Council decided a monthly Town Council Work Meeting would enable Town Council Meetings to be more efficient; and

WHEREAS, the Town Council decided a monthly Town Council Work Meeting would enable the Council more time to discuss details on agenda items, to prevent agenda items from being unnecessarily and repeatedly continued, and

WHEREAS, the Town Council of the Town of Leeds recognizes the need to change the Town Council Meeting days from the second and last Wednesday of each month; to a Work Meeting on the second Wednesday, and a Town Council Meeting the fourth Wednesday of each month; and

WHEREAS, the Town Council of the Town of Leeds further recognizes the need to change the Town Council meeting in November 2009 to the 3rd Wednesday, and the December 2009 Town Council Meeting to the 2nd Wednesday. Should a Work Meeting be needed in November and December, proper notice of such meeting date and time will be provided.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LEEDS, UTAH, THAT THE FOLLOWING SHALL BE ADOPTED:

1. The Leeds Town Council will conduct the Work Meetings on the second Wednesday of each month, unless proper notification given, at the Leeds Town Hall, and shall begin at 7:00 p.m.
2. The Leeds Town Council will conduct Town of Leeds Council Meetings on the fourth Wednesday of each month, unless proper notification given, at the Leeds Town Hall, and shall begin at 7:00 p.m.
3. The Town Council meetings in November and December will be modified to adjust for the Thanksgiving and the Christmas Holiday dates. For the 2009 Schedule, the November Town Council Meeting will be held on November 18

and the December Town Council Meeting will be held on December 9. Should a Work Meeting be needed in November or December, proper notification will be given.

4. This Ordinance shall become effective on December 11, 2008.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LEEDS, UTAH TO ADOPT THE LEEDS TOWN COUNCIL MEETING SCHEDULE ORDINANCE THIS 10Th DAY OF DECEMBER, 2008.
