## ORDINANCE 2010-02

AMENDING ORDINANCE 2009-17 OF THE TOWN COUNCIL OF LEEDS, UTAH, ESTABLISHING RULES AND REGULATIONS PERTAINING TO THE COLLECTION AND DISPOSAL OF SOLID WASTE PRODUCED OR GENERATED WITHIN THE BOUNDARIES OF LEEDS, UTAH, AND ESTABLISHING FEES FOR COLLECTION AND DISPOSAL OF RESIDENTIAL WASTE.

WHEREAS, Washington County Special Service District No. 1 was duly created by resolution of the Washington County Commission for the purpose of developing and implementing a system for the collection and disposal of solid waste generated within the boundaries of said District; and

WHEREAS, the incorporated area of Leeds, Utah is located within the boundaries of said District; and

WHEREAS, said District and Leeds have entered into a written Agreement dated July 30, 2008 governing collection and disposal of residential solid waste generated within the boundaries of Leeds for the period of January 1, 2010 through December 31, 2019; and

WHEREAS, said Leeds Town Council desires to establish rules and regulations, including monthly fees, pertaining to collection and disposal of residential solid waste generated within its boundaries; and

WHEREAS, said Town Council now deems it necessary and desirable for the preservation and protection of the general health, safety and welfare of the residents of Leeds, Utah,

NOW THEREFORE, BE IT HEREBY ORDAINED by the Mayor and Town Council of Leeds Town, State of Utah, as follows:

1. Paragraph 7(b) of ORDINANCE 2009-17 is amended to read as follows: "The amount of \$4.35 per month per residence, or such other amount as may be specified by a resolution approved by the affirmative vote of 75% of the members of District's Administrative Control Board, for operation of the Washington County Landfill and District's administrative expenses, and"
2. BE IT FURTHER ORDAINED that this Ordinance shall take effect on January 1, 2010, after publication and posting required by law, and shall supersede any other ordinance or provision in conflict with the terms hereof.
