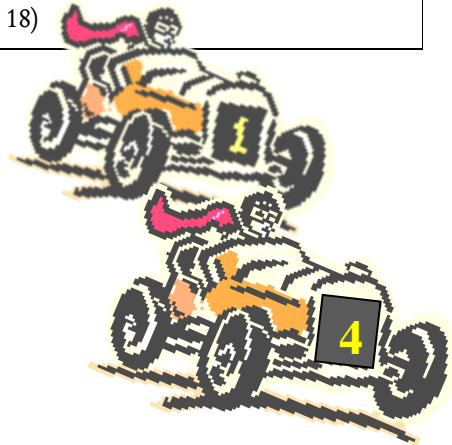

I certify that there are no health-related reasons or problems which preclude my participation in this activity or event.

FOR AND IN CONSIDERATION of the opportunity to participate in the event or activity identified above (the "Event"), I, the undersigned participant ("Undersigned"), hereby remise, release, forever discharge and covenant not to sue the Town of Leeds, a Utah municipal corporation, its agents, representatives, officers, employees, successors, assigns, and insurers, the Event holders, the Event sponsors, Event volunteers, whether herein named or referred to or not, and who, together with the above named, may be jointly or severally liable to the Undersigned, for and from any and all manner of actions and causes of action, rights, suits, covenants, judgments, claims and demands whatsoever in law or equity, arising from and by reason of any and all known and unknown, foreseen and unforeseen injuries, losses, damages, or claims which heretofore have been, and which hereafter may be sustained by the Undersigned as a result of my participation in the Event.

THE UNDERSIGNED ALSO EXPRESSLY DECLARES AND AGREES, on behalf of themselves, their heirs, estate, agents, family members and insurers, whether herein named or referred to or not, that this Accident Waiver, Release And Covenant Not To Sue covers and includes all claims several or otherwise, past, present or future, which can or may ever be asserted by *any* person or persons, as heirs, or otherwise, as the result of injuries or damages as aforesaid or the effects or consequences thereof.

THE UNDERSIGNED ALSO EXPRESSLY DECLARES AND AGREES that he/she/they will indemnify and hold the Town of Leeds harmless against loss, including attorneys fees and/or subrogation costs, from any and every claim or demand of every kind and character, including claims for contribution, which may be asserted by medical providers or insurers of the Undersigned.

THE UNDERSIGNED EXPRESSLY ACKNOWLEDGES that they have been informed by the Town of Leeds that the Event involves a risk of serious injury, death and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, weather, equipment, vehicular traffic and actions of other people including, but not limited to, participants, volunteers, spectators and Event officials. These risks are inherent to participants and volunteers.
